## What is a CLT?

Community Land Trusts (CLTs) are a well-established form of community controlled and owned body, with an open democratic structure.

They provide permanently affordable housing and other community assets.

# Who manages all of this?

- The CLT is incorporated as a Community Interest Company (CIC) with a board of directors who are local people. All CLT members, including the Board, work voluntarily. Any surplus funds are used for community benefit.

- Our current Registered Housing Provider (RHP), is White Horse Housing Association. White Horse manages Hook Hollow in Seend Cleeve on our behalf.

# Why should I join?

Strong membership, a housing development we have created gives us the track record credibility to apply for grants and loans, to engage with the local authority for support and to be representative of our community. Our CLT is an active full member of the National CLT Network.

#### How do I become a member?

Any adult of 16 years of age and over **who lives** in the parish of Seend, or with a Parish connection, can become a member for £1 for life. Be a member – strengthen our CLT.

# What has this got to do with me?

- 2016 and 2019 Rural Housing Needs Surveys showed a need for affordable housing, particularly for young families and people of retirement age.
- Currently there are no acceptable plans for private house builders, Wiltshire Council or Housing Associations to provide these homes. Home prices in our parish are 9 to 10 times average annual income. There is evidence that Right to Buy, Buy to Let and second and holiday homes are having an impact on housing availability. Family startups and singles, both young and old, are forced to move from the parish to meet housing need.
- There are sites in our Parish, owned by private individuals, that could be developed for new affordable, shared ownership and self-build housing. A local CLT can build affordable housing with priority given to those with Seend parish connections.
- Following a 2017 survey, many residents attended two public meetings and were overwhelmingly in favour of forming a CLT for Seend.
- The English housing market has changed, particularly in rural areas. Communities are using the Localism Act 2011 to do it themselves. You may now apply for shared ownership or rental homes through <a href="http://www.homes4wiltshire.co.uk">http://www.homes4wiltshire.co.uk</a>
- Legislation now provides means for CLTs to take ownership of housing development in their designated locality. CLTs become a recognised community forum with a powerful voice backed up by a strong neighbourhood plan.
